Introduction, Goal, and Trends

Introduction

This survey was delayed 11 months due to COVID-19. The purpose of this NH Early Childhood and School Age project was to obtain information from the 765 licensed providers about their programs on January 20, 2021, with a printed survey mailed to them on January 18, 2021. The survey included 35 questions regarding program type and size, program schedule, quality indicators, enrollment, attendance, CCDF scholarships, rates by child age, average staff wages, and COVID-19 impacts. Please see Appendix A for details. The UNH Survey Center was utilized for initial follow-up calls to help reach the target response. Contractor efforts to complete the project took significant additional time than anticipated. Two drawings were held as incentives to respond and to confirm the valuable work of NH providers.

Goal

The goal was to survey at least 60% of licensed NH early childhood and school age programs. Out of a total of 765 programs, the final response rate was 66.14% (N=506), of which 500 surveys (65.36%) were able to be analyzed. The goal of achieving a 60% response rate from each region was also achieved. Response rates varied by question.

Trends

According to the 2020 census, via NH Morning Edition August 26, 2021, New Hampshire's population increased by 4.6% over the last 10 years, the second-highest percentage in New England after Massachusetts. The largest growth was in Belknap, Rockingham, and Strafford counties (+6%), while Coos county was the only NH county to lose population (-5%) and estimates are that this trend will continue. The greatest population increases were in Rochester (+9%), Dover (+9%), Lebanon (+9%), Manchester (+6%), and Nashua (6%). Significant population decreases included Berlin (-6%), Colebrook (-9%), Lancaster (-8%), Claremont (-3%) and Keene (-2%) (https://www.nhpr.org/nh-news/2021-08-12/census-nh-latest).

The growth in NH population is overwhelmingly due to migration (>80%), with just 6,500 more births than deaths in the last 10 years, significantly less than in the previous decade. Estimates

indicate that the older population in the state is increasing while the younger population is decreasing. New Hampshire is now the fourth oldest state, with 81% of residents 18 or older.

Gibson (9/2/21) noted "The overall number of New Hampshire residents under age 18 declined by 10.6 percent over the last decade, according to an analysis of census data from the Carsey School of Public Policy at the University of New Hampshire.... The number of kids enrolled in public schools has been declining by 1-2 percentage points each year, and that trend increased during the pandemic". (https://www.nhpr.org/education/2021-09-02/child-population-in-nh-smaller-but-more-diverse). This trend will have continuing impacts on early childhood and school age program planning.

Similar to changes across the country, New Hampshire is becoming more racially and ethnically diverse. "In Manchester, the percentage of non-white kids is 43.1 percent. In Nashua, it is 45.4 percent" (Gibson, 9/2/21). Consideration should be given to training more minority providers.

The number of licensed programs continued to decline, from 1207 in 2001 to 834 in 2018 to 787 in 2020, including 22 residential programs. Center based programs continue to grow while Family and Family Group providers decline.

The impact of COVID-19 on providers, families, and children has been severe, and with the Delta variant increasing now, it will continue to negatively impact programs. Additional programs may lose staff, and temporarily reduce enrollment, downsize, or close. The financial impact has been and may continue to be severe.

In conclusion, continued changes will present challenges to planning for future early childhood and school age initiatives, and for supporting providers and programs during these changes.

Key Findings

Number of Licensed Programs

There were 765 NH licensed programs in December of 2020. There has been a continual, gradual decline in the number of licensed NH programs over the last two decades, and 25 fewer programs than in the 2018 Market Rate Survey.

Licensed Capacity

Consistent with US trends, mean licensed capacity has increased, from 38.49 children in 2001 to 59 in 2021, and increased from 54.74 in 2018. Program size increases do not necessarily recapture children from programs that have closed. For example, when one program closes, a parent may not be able to immediately find an available slot in an affordable, nearby facility.

Program Types

Center based programs continue to be the largest segment, increasing from about one-third (32%) in 2001 to 247 (53.00%), half of all programs in 2021. The percentage of proprietary programs has risen slightly to 59.13% from 52.2% in 2018.

Provided Service on Wednesday, January 20, 2021

Of the 493 programs that responded to this question, 419 respondents (84.99%) provided a program for children on Wednesday, January 20, 2021, while 74 (15.01%) did not. The response rate for this question was 98.60%.

Licensed vs License Exempt

466 respondents (100%) were licensed while 0 licensed exempt programs. The response rate was 93.20%.

Licensed Number of Children to Serve

The range of licensed number of children to serve responses was wide, from a minimum of 5 to a maximum of 432, with a mean of 59 and a median of 45. The response rate was 91.40%.

Proprietary vs. Not-for-Profit


More than half of the licensed programs that responded to this question (59.13%, N=272) were *proprietary*, while the rest (40.87%, N=188) identified themselves as *not-for-profit*. The percentage of provider-reported *proprietary* programs has increased from 52.2% in 2018. The response rate was 92.00% (N=460).

Types of Programs

In New Hampshire, the highest percentage of licensed programs were *Child Care Centers* (53.00%, N=247), almost unchanged from 51.49% in 2018, followed by *School Age (only) Programs* (11.80%, N=55), *Family Child Care Home* programs (9.01%, N=42), *Family Group Child Care* programs (8.37%, N=39), *Nursery Schools/Programs* (7.73%, N=36), *Head Start* (5.36%, N=25), *Other* (3.00%, N=14), and *Montessori* programs (1.72%, N=8). The response rate was 93.20% (N=466).




Quality Indicators

- Among 440 responses (a response rate of 88.00%), 126 (28.64%) indicated their programs were *Licensed Plus*.
- Fewer programs were *NAEYC Accredited*. Among 421 responses (a response rate of 84.20%), 44 (10.45%) indicated their programs were *NAEYC Accredited*.

Schedule

Almost half of the programs (50.00%, N=233) offered parents options of *full and partial day* care, and almost a third (31.97%, N=149) offered *full day only* care. The rest (18.03%, N=84) offered *partial day only* schedules. The response rate was 93.20% (N=466).



Months of Operation

Fewer than half of the programs (43.40%, N=217) operated throughout the year, a significant drop from 2018 (76.57%). Overall, on average programs were closed about one-fifth of the year, or about 2.5 months last year. (A program that operated throughout the year has 100% of *Months of Operation*, while a program that operated only one month has one-twelfth or 8.33% of *Months of Operation*.)

Days and Hours of Operation

Programs in New Hampshire operated within a broad range of hours per week (from 7.5 to 120 hours), with an average of 45.11 and a median of 50 hours. These figures remain consistent with the data from 2018 (45.60 and 51.25 hours respectively). Among the 419 programs that responded, none offered care during the weekend. Average hours of operation per day also had a wide range, from 1.5 to 24 hours. Data from both categories can be found in the tables below. The response rate was 81.60%.

Registration Fee

The response rate was 93.20% (N=466). Among those that did charge a registration fee, which accounts for about two-thirds (69.10%, N=322), it ranged from \$10 to \$400, with a mean of \$69.51 and a median of \$50.00.

Sliding Fee Scale

Nine out of ten programs (90.00%, N=414) did not offer a sliding fee scale to parents, while 46 (10.00%) did. The response rate was 92.00% (N=460).

Special Care Services

Only 4 (0.80%) programs offered special care services, a decrease from 11 (1.97%) in 2018. Among those, 3 provided care from 7 to 9 PM, 1 provided care from 9 to 11 PM, 2 provided overnight care, and none provided care primarily for sick children.

Licensed Capacity, Enrollment, and Attendance

We wanted to differentiate Licensed Capacity (the maximum number of children a program has been licensed to serve), the Desired Capacity (the number of children a program would like to enroll), the Actual Enrollment (the number of children a program had enrolled on January 20, 2021), and Attendance (the number of children attending on that day).

Charges to Scholarship Families

- About half (50.23%, N=219) of licensed programs received CCDF scholarship reimbursements from DHHS. The response rate was 87.20% (N=436).
- The same question was asked for the last two years, with a response rate of 89.40% (N=447), and 64.88% (N=290) said *yes*.
- For children whose families receive the NH Child Care Scholarship, more than half of the programs (59.64%, N=263) charged the DHHS-assigned cost share to parents while 12.93% (N=57) did not. The remaining chose '*Does not Apply*'. The response rate was 88.20% (N=441).
- For those that did charge a cost share for children enrolled full time in December 2020, the total cost share charged for that month ranged from \$12.00 to \$15,848.00, while the total cost share range for children enrolled part-time in December 2020 for the month was from \$16.77 to \$2,568.90. The response rate was 22.00% (N=110) and 12.20% (N=61) respectively.

• For those that charged a co-pay, the total charged in December for children enrolled full time ranged from \$25.00 to \$5241.14, while the total part-time range was from \$27.00 to \$834.00. The response rate was 20.00% (N=100) and 10.20% (N=51) respectively.

Reasons for not accepting DHHS scholarships

For those that did not accept DHHS scholarships, the leading reason was *no eligible families applied* (65.22%, N=60), followed by *other* (21.74%, N=20), the process is too complicated (7.61%, N=7), and *bad experiences with parents who did not pay their cost share* (5.43%, N=5). 92 responded to this question and the response rate was 18.40%.

More than a third (37.68%, N=188) of programs closed for staff professional days in 2020, and the number of such days ranged from 1 to 13 days with the mean and median of 2.38 and 2. About two-thirds (63.94%, N=289) of responding programs indicated that they had staff out due to COVID-19 in 2020. The response rate was 90.40% (N=452).




NH Full-Time Rate Comparison by CCR&R Regions

Another approach to understanding market rates in childcare is to consider variations across discrete geographic regions. For example, one might expect to see urban-rural differences, or north-south differences.

- When it came to program count in terms of care being available, overall, the sum from the Southern, Eastern, and Central regions roughly made up 80.00% of all programs across all full-time age groups. The Southern region is roughly twice as big as either the Southern or the Central.
- Rates charged for children served were consistently highest among the Southern and the Eastern regions, while the lowest from the Northern region. School age care rates received from both the Northern and Southwestern regions were at 3 or below, not enough to provide meaningful aggregation result.
- Average rates cross all age groups from the Southern and Eastern regions were at or above the overall state average, while the remaining three regions were below.

Opened and Closed Classrooms

 - 80 programs (18.69%) opened more classrooms in 2020 while 348 programs (81.31%) did not.
 - The response rate was 83.76% (N=428).
- Closed Programs
 - 101 programs (24.63%) closed more classrooms in 2020 while 309 programs (75.37%) did not.
 - \circ The response rate was 80.23% (N=410).

Staff Wages and Salary Changes



Salary Changes Due to COVID-19

- 426 programs responded to this question. The response rate was 83.27%.
- Among those that responded
 - 270 programs (63.38%) had no changes in staff salaries.
 - 138 programs (32.39) increased staff salaries.
 - 18 programs (4.23%) decreased staff salaries.

Remote Learning

443 programs (86.69%) replied as to whether they offered their program remotely at any time in 2020. Among those, 126 programs (29.44%) offered their program remotely while 317 programs (71.56%) did not. 45 programs offered their full-time programs remotely and 90 programs offered their part-time programs remotely.

Changes Due to COVID-19

Providers had much to share about the impacts of COVID-19 on their programs. Their comments filled a total of eight single spaced pages in response to an open-ended question about changes due to COVID-19. Responses were analyzed to discover patterns and organized them in the following broad categories.

General COVID-19 Health Procedures

Providers specified the measures they took to try and prevent the transmission of COVID-19 during 2020. Nearly universal measures included temperature and symptom screening of children, frequent hand washing, masking of staff and children, significantly increased cleaning, social distancing, increased air flow, and updated policies and procedures. A handful of programs set up quarantine/isolation areas. Field trips and events were canceled.

Limiting Access to the Facility

For many providers, this included a policy that only children and staff could enter the facility; no parents were allowed to enter. A few allowed parents to enter the facility but not any classrooms or allowed only one parent at a time to enter. Many noted that they also barred volunteers and visitors from entering the program.

Drop Off and Pickup

Often, providers had "runners" bring children to and from cars or at a specific location outside the building. Some programs hired additional staff to perform this function. A few received and released children at the door. Several programs staggered their drop off/pickup times.

Classrooms

The largest number of comments received related to reduced class sizes. To the degree possible, providers utilized many spaces to accommodate a larger number of groups that were comprised of fewer children per group. Often windows remained open, and in some program's fans and/or air purifiers were installed. Other providers took their classrooms outside, some for entire days, and in some cases for months, and in at least one case for 12 weeks. Playgrounds were reconfigured and, in a few instances, tents were erected. Programs also created remote and hybrid options. One program closed for a period but had teachers read stories to children on a private Facebook page during that time. At least a handful tore up their carpets and replaced them with linoleum. Some programs reported that they adapted their School Age program(s) to a full-time option to accommodate students who were not attending school in person.

Children

Most often, children were organized into cohorts that remained together throughout the day. Many reduced the size of these cohorts, or the size of groups, which then changed the teacher/child ratios, in most cases requiring more staff. Some programs with reduced numbers of children combined groups, or at least a few children from another group to create a mixed cohort. Other programs with more robust numbers split their pre-COVID-19 classroom group into two cohorts. Children could no longer bring soft materials from home and found that stuffed animals at their facility had been removed.

Program Hours

Many providers reported they were open reduced hours, to some degree to allow time to sanitize classrooms every day.

Costs

There was a high cost to programs as a result of COVID-19. The second highest number of comments had to do with the need to hire additional staff for the additional, but smaller cohorts, and the changed drop off/pickup procedures. Cleaning supplies, anti-bacterial dispensers, masks, gloves, thermometers, sneeze guards, disposable bibs, etc. added to program costs. A change to remote learning required new equipment and technology. Some programs increased salaries to existing staff as "hazard pay". A few lost staff to COVID-19 or found staff had to stay home because of exposure. Some programs found many staff stopped working because of COVID-19. One center-based provider reported that she was evicted by the landlord, had to quickly downsize by half to a home-based program, and lost \$10,000. Lowered enrollment was the third highest number of comments and inflicted significant lost revenue. One had a long waiting list but could find few applicants for staff that had resigned. In many programs, staff hours were cut.

A number of providers did not charge parents while children could not attend due to COVID-19 quarantine. In some cases, providers continued to pay staff while they were quarantined.

Other Impacts

Some programs operated with fewer staff. Some worked long days and extra hours to ensure that their classrooms were sanitized. One director reported working 55+ hour weeks for a significant period of time to keep her program afloat. Another reported that the greatest impact was "high stress".

Survey Methodology, Verifications, and Acknowledgements

Methodology

Survey Sample

A list of 787 licensed programs was provided by DHHS on February 19, 2020. A Master List was then created and utilized to generate labels for envelopes of the outgoing survey packets. COVID-19 delayed the project for approximately 11 months.

Survey Development and Design

Minor changes were made to the first page of the two-page survey protocol for two reasons: a) to allow comparisons between results from this survey and previous surveys to help identify changes over time and trends, and b) to retain familiarity for providers with previous survey questions. New questions were added regarding CCDF scholarships, and staff professional development days.

The second page of the survey included a reorganized format for questions regarding rates, whether more classrooms were opened or closed, and average staff wages.

COVID-19 related questions on both pages requested information on staffing impacts, staff salary changes, remote learning, and other changes due to COVID.

Survey Distribution

Surveys were mailed to every licensed childcare and early education program on January 16, 2021, with estimated arrival January 17-21. The survey packet contained brief Instructions, the two-page survey, and a Market Rate Prize Drawing Ticket. Providers were requested to return their survey by February 4, 2021.

Telephone Follow Up Calls

The UNH Survey Center was utilized to conduct follow up calls to achieve the target response rate, while allowing for the elimination of any unusable surveys and still exceeding the 60% response rate goal. A few surveys continued to arrive by mail. The final response rate achieved was 65.69%, with a usable response rate of 64.93%.

In addition, Market Rate Survey program staff made a considerable number of calls to obtain data not provided, to correct mistakes, and to clarify confusing responses from licensed programs. This took much more time than anticipated.

Market Rate Survey Verifications

Child Care Aware of New Hampshire, a program of Southern NH Services handled the Verification process. Details may be found in the next section.

Market Rate Prize Drawing

There were two separate prize drawings. To encourage a prompt mail response, the initial drawing was held on February 3, 2021, for those providers with completed surveys that were returned or postmarked by January 29, 2021.

Providers that returned a completed survey by the end of March were entered in a Gift Card drawing for smaller gift cards for Market Basket, Hannaford, Shaw's, Staples, Barnes & Noble, Irving, Amazon, Dunkin Donuts, or Walmart.

Verifications

To verify the accuracy of provider responses for rates charged, project staff randomly selected 6.85% of responding center-based and home-based providers, and then randomly selected for each selected provider a single age category and their most common Time Period (e.g., Week, Day etc.) on which to base the verification. That information was provided to Child Care Aware of New Hampshire, a program of Southern NH Services (SNHS CCAoNH). Project staff requested the highest rate each selected provider charged parents for full-time care for one randomly selected program (Infant, Toddler, Preschool I, Preschool II, or School Age). This method ensured other program details on survey responses remained confidential, and that there was no possibility of other market rate survey responses influencing SNHS CCAoNH data.

An 6.85% randomly selected response [N=35] for validation was achieved, exceeding the required target of 5%, with a majority of selected programs [N=21] having a match between the rates they provided on the Market Rate Survey form, and the rate that SNHS CCAoNH independently recorded.

Minor rate changes of less than 5% were considered within a normal range. Some providers may have recently changed their rates slightly up or down to retain families and/or make ends meet. In general, existing rates were accurate at the time of the survey and at the time of SNHS CCAoNH collection. SNHS CCAoNH did offer a rate update in 2020 but due to COVID-19 not all providers (N=6) updated their rates so SNHS CCAoNH retained the last rate reported in their database, which in a few cases may have been older than a year. Those programs were eliminated from the verification process. Two providers which showed a greater than 5% rate discrepancy were contacted. One program had recently changed hands and the new provider increased her rates. The second provider has not yet responded to phone messages. In no case did we find an intentional effort to record a rate that was not an accurate reflection of prices charged parents. Licensed New Hampshire providers submitted reliable rate responses on the Child Care Market Rate Survey.
