Coronavirus Response and Relief Supplemental Appropriations Grant Award: What is It?

Purpose of Award:

- Healthy, safe and stable services
- Program recovery & stabilization
- Stronger child care system infrastructure
- Support families

Coronavirus Response and Relief Supplemental Appropriations Grant Award: What is It? (continued)

For Programs:

- Provides Funding & Support for COVID-related Costs and Stabilization (operations, workforce, health & safety)
- Funding Amounts Based on Available Funding & Program Needs & Capacity
- Funds must be Expended by September 30, 2022

Coronavirus Response and Relief Supplemental Appropriations Grant Award: Who is Eligible?

Programs with license in good standing, including:

Licensed Family Child Care Homes, Family Group Child Care Homes, Group Child Care Centers, Child Care Nurseries, School Age Programs, Night Care Programs, License-Exempt Centers and License-Exempt Providers (Friend/Neighbor only)

Summer Day Camps and Municipal Recreation Programs providing child care

Please note: License –Exempt Providers that are related to the children in your care are not eligible

Coronavirus Response and Relief Supplemental Appropriations Grant Award: Who is Eligible? (continued)

You must:

- Be a located in New Hampshire
- Have a program physically located in NH
- Provide services to NH children at least 75% of children residing in NH
- Open or planning to reopen your program by June 30, 2021 (flexibility to be considered based on school district schedules)

Coronavirus Response and Relief Supplemental Appropriations Grant Award: How can funds be used?

- Employee wages and/or one-time bonuses
- Income losses
- Operating and/or occupancy costs
- Materials and/or supplies
- Staff development and/or training
- Parent fees

Coronavirus Response and Relief Supplemental Appropriations Grant Award: How will programs be selected for funding?

- Fair/equitable review process
- Complete application
- Meeting criteria for eligibility



Coronavirus Response and Relief Supplemental Appropriations Grant Award: How will funds be awarded? and paid

FUNDING IS NOT FIRST COME, FIRST SERVE!

Child Care Centers will receive an award based on the following formula.

- Number of classrooms;
- Number of staff directly serving children and families at least 51% of the time; and
- Percent of children enrolled and receiving NH Child Care Scholarship.

Family Child Care Providers and License-Exempt Home Providers will receive awards based on the following formula.

- Flat rate per size
- Number of children receiving Child Care Scholarship




