What are American Rescue Plan Act Discretionary Funds?

- Managed through Administration for Children and Families-Office of Child Care (OCC)
- Total award: \$29,736,767
- Funds must be encumbered by September 30, 2023
- Funds must by fully expended by September 30, 2024

What is the purpose of the ARPA Discretionary funds?

- 1) Build an even better child care system
- 2) Help more families afford quality child care over next 3 years
- 3) Help states meet their federal mandate under civil rights law to provide equal access to child care programs, services & activities, including high quality programs

How do ARPA Discretionary funds fit into the overall plan for the child care community & its stakeholders?

NH's 3-phased approach to supporting child care for children, families, providers, & business community:

Phase 1: Emergency Response (3/17/20 – 6/15/20) Phase 2: Recovery & Stabilization (6/15/20 to 12/30/20)

Phase 3: Long-term Stabilization, Sustainability & Capacity Building (1/1/21 – TBD)



How did we develop the ARPA Discretionary Plan?

- > 6 months gathering input & recommendations
- > Outreach webinars, discussions, dedicated email box, social media, & website postings...plus ongoing training & technical assistance from OCC
- > 400 individuals and organizations provided input
- > Online survey 430 responses from over 56 organizations, entities & individuals
- > 19 stakeholders convened in series of meetings to identify top priorities

What are the priorities for NH's Plan?

- Stakeholders identified priorities in 3 categories: workforce, children & family needs, & provider needs
- Additional priorities to:
 - Strengthen child care system infrastructure
 - Partner with businesses
 - Help mitigate cliff effect



Key takeaways in planning from OCC guidance & technical assistance

- Take time to plan strategically, leverage relationships & current projects while creating new pathways & solutions
- View Plan as evolving & responsive strategy, responding to changes, initiatives, priorities, partnerships & conditions in your state
- Think long term, beyond basic stabilization, invest in the future – children, families & child care

Strengthening the Workforce



- Child care/Head Start workforce recruitment & retention
- Early childhood/out-ofschool time career exploration & expansion

Partnerships with NH Businesses & Employers

- Business/child care partnership program
- Business/employee surveys
- Public awareness campaign
- Business/child care network group
- Technical assistance & resources for employers/employees



Child Care Supply Building



- Family child care startup/expansion
- Program expansion via facilities modifications

Family Equitable Access to Affordable, Quality Child

- CCDF Pilots:
 - Increased income eligibility for families at initial determination
 - "Pay by enrollment " data pilot
 - Implement Early Head Start model in infant/toddler child care
- Absent due to COVID policy extension



Quality Improvement

- Granite Steps for Quality (GSQ), NH Quality Recognition and Improvement System)(QRIS)
 - Validation study
 - Quality incentives for programs
 - Assessment tools & materials
 - Professional development activities to implement
- Increased access mental health (MH) supports/services for staff, children & families via self-care/wellness training/technical assistance/support to staff
- Increased access community MH services for children in early childhood & out-of-school time programs

Infrastructure Building

- Support regional child care networks to strengthen child care communities
- Leveraging partnerships
- Build on existing foundations
- Expand vision for the future
