## **Updates from the Bureau: Andrea**

Andrea shared Charts and Graphs sharing data around GSQ throughout the State

- 141 awarded in GSQ
- 14 Awarded in L+
- 5 accredited programs opting not to join GSQ
- 546 programs licensed but not participating
- 9 applications on deck - all are awaiting documentation

## **Endorsement Update:**

54 Programs currently hold the Family Engagement Endorsement  
52 were automatically awarded based on being NAEYC or Head Start

A handful did the Strengthening Families training and got endorsement  
One of these programs is not in GSQ

FEEDBACK: In general, programs really liked being able to shop for what they wanted rather than just receiving a toy kit

## **GSQ Capacity Build contract updates**

### **Credential Incentive:**

- Credential Incentive ends on 9/30/24.
- All credential recipients must complete their survey by 9/30 in order to receive the \$100 gift card.
- 495 people have been credentialed since July 2023
- 403 recipients have claimed their gift card

### **Tuition Incentive:**

- \$500,000 for CCSNH has been awarded!

## **ERS Updates:**

- Introduction to the Environment Rating Scales (ECERS, ITERS, FCCERS) now available on ProSolutions - programs required to take training for Step 1 in GSQ or to earn PD hours for licensing.
- ERS tool books and Coaching with ECERS books available at no cost to programs if requested, contact Child Care Aware for materials
- Engaging with 15 Step 1 ERS programs for Readiness Series (May-August 2024), upon completion these programs will be paired with a coach to work on individual program goals and CQI plans

## **Other Incentives/Updates:**

- All programs engaging in training, coaching, and pilots have received high quality materials, books, and toys including but not limited to:
  - Family Engagement Endorsement with \$500 Kaplan award (flier here: <https://www.nh-connections.org/wp-content/uploads/2024/05/GSQ-Family-Engagement-Endorsement.pdf>)
  - Kaplan diversity kits worth \$800 shipped directly to ERS programs
  - Pyramid Model social-emotional kits sent directly to all PM Programs
  - Chalk spinners (<https://kodokids.com/product/chalk-spinner-blue/>) sent to NAEYC programs for taking part in focus group activities for NHAIEYC and GSQ ease of entry and feedback
- Seven programs completed Mixed Delivery Pilot which focused on standards within GSQ Steps and beyond including curriculum, child assessment, child screening, and program policy updates

**Joining, staying, progressing & How to make it better**

**“GSQ Evaluation Plan & Validation Study 101”** - Megan: BHII

Performance monitoring - process measures - key performance indicators relative to goals or targets

- Used to monitor and adjust implementation in real time
- What or how much is happening
- How many programs are participating in GSQ over time and by step

Evaluation - using scientific methods to investigate relationships between program components

- Used to better understand what predicts or drives process/outcomes
- Why or how is it happening
- What program factors (size, type, geography) predicts GSQ participation/step

Validation - using scientific methods to investigate whether it measures accurately/what we want it to

- Used to make sure our measures have intended “real world” meaning
- Are we using the right measures
- Do programs at higher GSQ steps (measure of quality) have better child outcomes

***DRDP under strong consideration as a suggestion to measure child outcome and success in the system***
